2. Public Outreach Activities Regarding Senate Bill (SB) 1383 Requirements

Martin noted that the Board has talked since last year about how to get the word out on the new SB 1383 requirements including the potential for holding large community workshops for various stakeholder groups. These workshops were delayed due to both the state and local regulatory process which was not completed until early this year. Since that time, Recology and RWMA staff have been reaching out and presenting to smaller targeted groups and organizations such as the restaurant association, property management companies, school districts, health facilities and the local jurisdictions and have found this approach to be very productive. As a result, staff believes that major community workshops would not be beneficial at this time.

Staff reported that the last community clean-up event of the year would be conducted in Wheatland on Saturday July 23, 2022.
