- Periodically inspecting Recyclable Materials Collection Program, Organic Materials Collection Program and solid waste services containers for contamination and informing employees if containers are contaminated to keep contaminants out of those containers. Ordinance Section 5(f).

Physical space waivers issued pursuant to Section 6(b) of the Regional Waste Management Authority's Mandatory Organic Waste Disposal Reduction Ordinance:

- Are issued on the condition that the entity notify the Regional Waste Management Authority if circumstances change such that the Commercial Business/Organization/ Agency's or Multi-Family Dwelling Property's physical space configuration(s) change, in which case the waiver will be rescinded.
- Are valid for a period of five (5) years after which written verification (new waiver application) of eligibility will need to be submitted.
